Instructions to Authors

Manuscripts for publication in the *Aircraft Design Journal* should be sent in triplicate to one of the following editors:

Only papers not previously published will be accepted, and authors must agree not to publish elsewhere a paper submitted to and accepted by the Journal.* All authors must sign the 'Transfer of Copyright' agreement before the article can be published. This transfer agreement enables Elsevier Science Ltd to protect the copyrighted material for the authors, but does not relinquish the author's proprietary rights. The copyright transfer covers the exclusive rights to produce and distribute the article, including reprints, photographic, reproductions, microform or any other reproductions of similar nature and translations, and includes the right to adapt the article for use in conjunction with computer systems and programs, including reproduction or publication in machine-readable form and incorporation in retrieval systems. Authors are responsible for obtaining from the copyright holder permission to reproduce any figures for which copyright exists. The language for the Journal is primarily English.

Page proofs will be sent to the author (or the first mentioned author of a paper of multiple authorship) for checking. **Corrections to the proofs must be restricted to printer's errors.** Any substantial alterations other than these may be charged to the author.

Authors are particularly requested to return their corrected proofs as quickly as possible to facilitate rapid publication. Please note that **authors are urged to check their proofs carefully before return, since late corrections cannot be guaranteed for inclusion in the printed Journal.**

Reprints and copies of the issue (at a specially reduced rate) can be ordered on the form which will accompany the proofs. These should be returned to: Elsevier Science Limited, The Boulevard, Langford Lane, Kidlington, Oxford OX5 1GB England. The first named author of each paper will receive 25 reprints free of charge.

* Prof. Roskam has stated that AIAA Papers, properly reformatted, are acceptable for submission. They should be identified as such and should not have been published in any other journal.

Manuscript Requirements

Manuscripts should be typed double spaced on one side of the page only with wide margins and submitted in triplicate. While no maximum length of contributions is prescribed, authors are encouraged to write concisely.

The title should be brief. The author's name should be typed on the line below the title. The affiliation and address should follow on the next line. In the case of co-authors, respective addresses should be clearly indicated, as well as which author is to receive correspondence and proofs for correction. Where possible, the Fax number of the corresponding author should be supplied with the manuscript, for use by the publisher. The body of the manuscript should be preceded by an abstract.

Illustrations are to be restricted to the minimum necessary. They should accompany the script and a list of figure captions should be supplied on a separate page. Line drawings should include all relevant details and should be drawn in black ink on plain white drawing paper or tracing cloth. Good photoprints are acceptable, but blueprints or dye-line prints cannot be used. Drawings, etc. should be about twice the final size required and lettering must be clear and 'open', and sufficiently large to permit the necessary reduction of size for publication. Photographs should be sent as glossy prints. If words or numbers are to appear on a photograph two prints should be sent, the lettering being clearly indicted on one print only.

Reference to published literature should be quoted in the text in square brackets and grouped together at the end of the paper in numerical order. Double spacing must be used throughout.

Journal references should be arranged thus:

Journal titles should be given full. It is particularly requested that author's initials, and appropriate volume and page numbers should be given in every case.

Footnotes, as distinct from literature references should be indicated by symbols: *, †, ‡, §, ¶, commencing anew on each page, they should not be included in the numbered reference system.

Because of the international character of the journal, no rigid rules concerning notation or abbreviation need to be observed by the authors, but each paper should be self-consistent as to symbols and units, which should all be properly defined.

Disks: For papers produced using a work-processor please submit a disk with the **final revised version** of the manuscript. The file on disk should correspond exactly to the hard copy. The operating system and the word-processor used should be specified clearly. Illustrations in electronic format may be supplied provided that the file format and the program used to produce them is clearly indicated and that a hard copy is also supplied. More detailed guidelines and further information are available from the publisher.

The original manuscript and diagrams will be discarded one month after publication unless the publisher is requested to return original material to the author.
